### Exemptive Request Letter Related to Timestamp Granularity

 On March 24, 2025, the Plan Participants submitted to the SEC a request for exemptive relief to extend the Commission's <u>April 8, 2020</u> <u>exemption order</u> relating to the granularity of timestamps accepted by the CAT system under Section 6.8(b) and Appendix D, Section 3 of the CAT NMS Plan, for an additional five-year period.

## CAIS Updates

### Proposed CAT NMS Plan Amendment Related to CAIS

- On March 7, 2025, CAT LLC filed with the SEC a proposed amendment to the CAT NMS Plan relating to the Customer and Account Information System (CAIS). Subject to notice and comment and SEC approval, the amendment would eliminate requirements that Industry Members report Customer names, Customer addresses, account names, account addresses, years of birth, and authorized trader names; would provide for the deletion of previously reported Customer information; and would achieve significant annual savings in CAT operating costs. The proposed changes to the CAT NMS Plan are set forth in Exhibit A of the filing.
- Comment Period for the Amendment ended on April 9, 2025.
