SEC Order Approving Proposed Amendments to the CAT NMS Plan (as modified by the Commission) Regarding Verbal Quotes

On May 28, 2025, CAT LLC filed with the SEC a <u>letter</u> responding to comments on the <u>proposed amendment</u> to the CAT NMS Plan relating to the Customer and Account Information System (CAIS), which was filed with the SEC on March 7, 2025. The proposed changes to the CAT NMS Plan are set forth in Exhibit A of the filing.

Billing Trade Details Files: Technical Details

- The Billing Trade Details Files are being split into separate files for TRF and exchange records, respectively, effective with the May 2025 invoice issued on June 25, 2025. This change is meant to assist Industry Members in their reconciliation processes. All other aspects of the schema, including field positions in CSV files, will remain unchanged. However, please note that the versionNumber field value will change from 1.1 to 1.2.
- This change will necessitate changes to the File name:
 - Current File Name:

CAT Billing: CAT Invoices
